September Wine Club Contest
Contest Rules & Regulations (“Official Rules”)**

How to Enter: NO PURCHASE NECESSARY. No purchase or payment necessary to enter or win. Purchase will not improve an entrant's chance of winning. The Contest commences at 12:00 a.m. PST on September 1st 2020 and closes at 11:59 p.m. PST on September 30th 2020.

There are three (3) ways to enter, as follows:(a)Eligible Purchase: Eligible entrants may visit <https://www.greatastatesokanagan.com/wineclub> and purchase any wine club membership for themselves or as a gift to be automatically entered to win. All entries must be submitted online no later than 11:59 p.m. PST on September 30th 2020. THE CONTEST CLOSING DATE. Participation is limited to one (1) entry per wine club membership purchase during the contest period. Web site tracking determines date and time of entry.
